TERMS AND CONDITIONS:

Joshua Generation Camps & Trainings

Dear Applicant,

Below are the terms and conditions for attending any of the Joshua Generation Camps presented. Please read these conditions carefully.

1) Definitions:

- a. Lion of Judah Ministries: is the overseeing organisation for Joshua Generation Camps.
- b. Project Leader: is the person or persons that are directly responsible for the entire operation of the camp.
- c. Staff: is any person that is part of the workforce and human resources for any Joshua Generation camp being employed full-time by Lion of Judah Ministries or only as a volunteer worker, no matter the involvement during the entire camp.
- d. Participant / Student: is any person that has registered for any Joshua Generation Camp or Training and is attending such.

- 2) Privacy & Confidentiality Statement: Lion of Judah Ministries is committed to protecting your privacy. All information collected from participants and their guardians throughout the registration process and training sessions are regarded as confidential and therefore will not be divulged to any third party, other than if legally required to do so to the appropriate authorities. We will not sell, share, or rent any personal information to any third party or use e-mail address for unsolicited mail.
- 3) Cancellation Policy: A non-refundable deposit is payable upon registration. The deposit amount varies depending on the type of Camp or Training presented - Please see relevant Application Forms for current pricing.
- 4) A participant or student that is attending the camp or training and does not complete such, shall not be entitled to a refund of the total amount payable.
- 5) Further, Lion of Judah Ministries (hereafter referred to as 'the organisation') may at its discretion and without liability or cost to itself, at any time cancel or terminate the participants registration, attendance and/or participation as staff, and in particular without limiting the generality or the foregoing, it shall be entitled to do so in the event of illegal or



other unseemly behaviour of the participant, who shall in such circumstances not be entitled to any refund.

- 6) Neither the organisation or any other person acting for, through or on behalf of the organisation shall be liable for any loss or damage whatsoever arising from any cause whatsoever, and without restricting the generality of the foregoing shall particularly not be responsible for loss or damage arising from any errors or omissions contained in its brochures, documents or other literature, late or non-conformation or acceptance of registration, loss or damage caused by delays, sickness, injury or death, whether occasioned by negligence or not. In addition, the organisation shall have the right at any time and at its own discretion to cancel the Joshua Generation camp or the remainder thereof or make any alteration en route, accommodation, price or other details and in the event of any course and/or outreach being rendered impossible, illegal or inadvisable due to weather, strike, war, government interference or any other cause whatsoever.
- 7) We further reserve the right to alter the itinerary of any camp or training without notice and at the discretion of the organisation prior to and throughout the camp or training as we are constantly improving the Joshua Generation camp experience. Itineraries may change due to, but not limited to: Severe weather; student ability; unpredictable natural disasters; vehicle breakdowns; grass and other fires; illness; any potential threat to safety. In the event of a schedule change, comparable activities will be substituted when possible.
- 8) Each participant that is a national from a foreign country (Non-Namibian citizen) must possess a valid passport and valid visa which may be necessary, and must comply with all immigration, customs and foreign exchange regulations. The organisation shall have no obligation whatsoever in respect of any of the items referred to in this paragraph.
- 9) The Project Leader/s appointed by the organisation shall at all times be in charge of the Joshua Generation camp and all matters related thereto, and all participants must abide by their decisions.
- 10) The following camp rules will remain applicable for the entire duration of any camp / training:
 - a. Communication between the participant and his / her parents or guardians and all non-camp parties will be limited to any major medical emergencies only or as otherwise approved by the Joshua Generation Camp designated Project Leader.
 - b. Participants will address all Lion of Judah Ministries personnel with utmost respect and will follow all instructions without question and to the letter.
 - c. No verbal or physical abuse of fellow participants will be allowed.
 - d. Participants are not allowed in the sleeping quarters of the opposite sex.
 - e. No alcoholic beverages, illegal drugs, tobacco products and dangerous objects such as lighters, matches, knives and firearms will be permitted at the camp.

- 11) All baggage and personal belongings will be housed and transported at the participant's own risk at all times.
- 12) All persons participating as student, staff member, or serving in any other capacity in the Joshua Generation Camps and Trainings under the guidance of the organisation shall so camp, travel, hike, abseil, cross bridges and rivers, motorboat, canoe, or any other mode of transport, entirely at their own risk, and the organisation does not accept responsibility or liability for any acts, omissions, default, neglect, delay, deviation or failure of itself or its servants if any, or fellow travellers, or any travelling services, hotels, boarding-houses, camp sites or their servants, for injury, damage or loss to persons or goods whatsoever or howsoever same may have been caused.
- 13) All persons participating as student, staff member, or serving in any other capacity in the Joshua Generation Camps and Trainings under the guidance of the organisation shall so participate in all camp activities entirely at their own risk, and the organisation does not accept responsibility or liability for any acts, omissions, default, neglect, delay, deviation or failure of itself or its servants if any, for injury, damage or loss to persons or goods whatsoever or howsoever same may have been caused.
- 14) All participants and students participating in the Joshua Generation Camps and Trainings will be exposed to physical exercise and fitness.
- 15) The applicant or the parents / guardian, in case of a minor, agrees and grants full permission to the organisation or any related or consulting / attending paramedic, physician and/or medical officer to the performance of emergency medical treatment and such treatment, anaesthetics and operations that, in the opinion of the consulting / attending paramedic, physician and/or medical officer, are deemed necessary. The organisation will not be responsible of any financial liability pertaining to medical treatment, emergency medical transport, and hospitalisation, and in the case of death, the transporting of and/or burial of mortal remains.
- 16) Should the applicant or the parents / guardian, in case of a minor, not agree to the foregoing term (Point #15) the organisation may at its discretion and without liability or cost to it self, terminate and/or prohibit the staff or participants participation, in any form, in any camp, training, conference, workshop and/or any other related work that is presented and/or attended by the organisation.
- 17) The organisation will not be responsible or accept liability in any way of any decision to apply emergency medical treatment and such treatment, anaesthetics and operations that, in the opinion of any representative or project leader, escort or other employee or agent of the organisation and/or the consulting / attending paramedic, physician and/or medical officer, are deemed necessary, fail and result in death, further injury of any kind, regression of state of health of any kind, amputation of limbs and/or a total or part of the staff / student's body being paralysed.

- 18) If possible at all, the leaders or any representative, project leader, escort or other employee or agent of the organisation will contact the family of the student / staff prior to any necessary medical treatment.
- 19) The organisation holds the right to publish images and / or video footage of the students participating in the camp on various social media applications such as Facebook, Twitter, Youtube and its own registered websites as well as using these materials for advertising of camps on various other media such as Television and DVDs.
- 20) Parents that do not agree to point #19 of this document must so state before camp start in writing.
- 21) No servant or agent of the organisation has the authority to vary any of the mentioned conditions in this paper or any other official paper belonging to the organisation unless done so as stipulated by the constitution. No representative or project leader, escort or other employee or agent of the organisation can authorise any liability whatsoever and the organisation will not be bound by any statement or representation unless it is in writing and signed by two duly authorised members of the Executive Committee.
- 22) Once the applicants registration has been accepted, these Terms and Conditions will be in force, whether the applicant or his / her parents or legal guardians have read and taken notice of such or not.
